艾兵博士在美國從事法律服務 23 年，是博欽律師事務所合夥人律師。他於 1981 年從陝西考入北京大學物理系讀本科並繼續鐳射物理專業碩士研究生。後赴美留學在美國南加州大學從事鐳射物理和非線性光學研究，獲物理博士學位。他在國際和美國的學術期刊及會議發表多篇鐳射物理研究論文，其中包括英國的《自然》學術雜誌 (Nature)、美國的《光學快報》(Optics Letters)、《應用物理學快報》(Applied Physics Letters) 及《美國光學學會期刊》(Journal of the Optical Society of America)。

艾兵博士于 1996 年轉入美國專利法行業，後獲美國加州聖地牙哥大學法學院法學博士，是美國加州的註冊律師及美國專利商標局註冊專利代理人。他先在美國律師所 Fish & Richardson P.C. 執業 14 年，後於 2010 年作為博欽律師事務所聖地牙哥分所的創始合夥人之一加入博欽律師事務所。艾兵博士的業務主要包括在美國以及全球的專利戰略與專利組合管理，美國專利訴訟，自由行使權分析，專利有效性分析，專利侵權分析，專利盡職調查，以及與企業融資、投資、並購相關的專利盡職調查。艾兵博士在專利管理和專利戰略戰術上經驗豐富，並在當代某些重要技術的專利的保護起到重要作用。

One particular area of Bing's patent practice is patent post-grant trials before the Patent Trial and Appeal Board (PTAB) of the U.S. Patent and Trademark Office under 2011 Leahy-Smith America Invents Act (AIA), including inter partes review (IPR), post-grant review (PGR) and covered business method (CBM) patent review. Bing is ranked as one of the top PTAB trial lawyers in the U.S. and is the co-chair of the firm's Post-Grant Trial Practice.

Bing has received various recognitions for his legal skills and client work, including "*The Best Lawyers in America*" in patent law (2019, 2018, 2017 and 2016), "*The World's Leading Patent Practitioners*" (2019, 2018, 2017, 2016 and 2015) and a Top Post-Grant Trial Practitioner by *Intellectual Asset Management* (IAM).
